

#### PASTOR'S ANNUAL REPORT FOR 2010

Are you an **Impatient Optimist** or an **Impatient Pessimist**? An "Impatient Optimist" is one who cannot wait to see what is going to happen in a joyfully anticipated future. An "Impatient Pessimist" is someone who expects the worst and is in a hurry to prepare for it. Which one are you? As we look back on the past year, I find myself eagerly anticipating how the next year will unfold.

This time last year, many were worried about our fiscal viability as we faced a large deficit. By God's grace, with a matching contribution, one anonymous donor was able to inspire increased giving from many of you – both from your own resources and the community around us. In this past year, the Session and an Ad Hoc Committee (known affectionately as "The Diggers") worked diligently and passionately to address the deficit before us and **it truly seems to be a miracle that we bucked the national trend** and have ended up with a bit of a surplus! I hope it will also be recognized how much fun we had raising much of those funds – "Give and Go" participation, "Time and Talent" auction, "Harvest of Gratitude" pots, "Valentine Giving", Congregational Garage Sale (aka PW Parking Lot Sale), and other opportunities not only raised money but gave us time together, working as a family to maintain our household.

There might be some who think we should have been working together on outreach projects, however, the reality is that as a "young congregation" with new buildings, we are still paying off a sizeable mortgage that has allowed us to provide important meeting space for many community groups (as you will see in the report of the Faith in Action Team which also reflects that this congregation is incredibly involved in outreach!). Additionally, "Bright Start" continues to thrive in this place as both child care (allowing many in the community to work knowing their children are in a loving environment) and pre-school preparation (setting up lifetime habits of learning for future members of our community); and more, it is also a supportive environment for parents to gain wisdom in order to raise happy and responsible children. Best of all: this building resounds with laughter and joy on a daily basis – something my colleagues envy with their empty buildings!

It is truly unbelievable how much this small church accomplished in the past year! "Small church"? Some of you might be bristling at the description – but it is a reality we've had to face as we "clean the rolls" in order to reduce our Per Capita expenses, as well as review the level of participation of all our membership. Do keep in mind that we continue to care for those who are listed on our "inactive members" roll. Naturally, I find good news even though the numbers are down. We have an excellent ratio of worship attendance to membership numbers (trending toward 85 people in worship on Sundays and growing) and, our numbers of actively participating young people continues to grow (over 40 of preschool age to 12th grade have been involved over the past year!).

While the Session and I are doing our best to encourage everyone to maintain or even increase their commitment to this congregation, we need your creative ideas as well as your constructive criticism! Many of us are "from away" and bring with us a wealth of ideas for what worked in other congregations. That also means we bring enormously varied perceptions of what "church" means. Like every family or committed relationship, we've got to keep our lines of communication open and make our expectations, as well as our disappointments and frustrations, known. Here's a confession: I recently wrote in my prayer journal "afraid I'm not meeting unspoken and unknown" expectations. Well that would be hard wouldn't it? Nothing is less helpful than to hear people are feeling left out or angry without some opportunity to resolve the problems! So I encourage everyone to feel free to meet with me, formally or informally – in my office, in your home, on a walk, or over coffee. I confess, I often skip meals, so help me out – keep your pastor fed and informed.

Another way to keep us informed might be to gather a few people together for a pow-wow of sorts. Maybe you have found yourselves gathered with other friends talking over dinner or dessert about what you wish we were doing (or not doing) – how much more useful it would be to include the pastor in these conversations. One of the continuing joys of this congregation is how often we do come together over meals. It has been a special gift to gather on holidays, both Easter and Christmas days saw some of us feasting together as a family. Other special events have also been marked with good food and laughter.

During my first year as pastor here, the Session and I spent many extra meetings addressing budgetary concerns and reviewing "Safe Church" policies. Our meetings were so "agenda-driven" and constrained by meeting times, we didn't have time to pray together and listen for God's direction. This year, the Session and I have added one monthly meeting for the express purpose of engaging in "The Practice of Spiritual Discernment." We will study scripture together, pray and learn together. I ask your prayers for us every 4<sup>th</sup> Monday of the month and throughout the year ahead. And please continue to join me in prayer at "10:10" wherever you are, we can pray together as a church – for each other, our community, and our world.

A couple of personal highlights from this year include representing the Presbytery of Northern New England as a commissioner at General Assembly in Minnesota this past summer as well as serving as the "President" of the Brunswick Area Interfaith Council. I initially agreed because we were in a fallow year (and it wouldn't be too demanding). Wondering what the future held, it has been very exciting to see the group re-energized by "The Gathering Place" (the Adult Day Center for those with nowhere to go during the day which will be peopled by volunteers from many area churches. Initially, over 50 have signed up to help – unheard of and MCPC members have been essential to bringing this to fruition).

One of my goals this past year has been to make the presence of MCPC better known in the community. The Cul de Sax Concert, "Fishes and Loaves", and the Volunteer Fair were good examples of how many people have yet to find us! "I didn't know this church was here" and "I didn't know there were Presbyterians in Maine" have been heard from visitors — why is it easier to find Wal-Mart than this wonderfully warm and welcoming congregation? I still dream of being a presence at the Farmers' Market . . . maybe you would like to help?

Even as I review the past year, I cannot help but look forward so here are some of my goals for the future:

• Continue to grow in numbers and participation level

- Continue to increase communication and strengthen relationships in the process
- Continue to make our presence known to the greater community
- Continue to preach the gospel as well as learn from all of your experiences

#### FAITH IN ACTION 2010 ANNUAL REPORT

The Faith in Action Team continues MCPC's long history of involvement in many local community outreach programs and support of worldwide outreach. This team encourages members to share their time and talents in these programs along with bringing new programs to the attention of the congregation. More than ever, we have been challenged to extend our involvement beyond charitable dollars.

Over the past year, the Faith in Action Team has addressed a number of issues including: SUSTAINABLE FISHING AND SUPPORT OF LOCAL BUSINESS: "Fishes and Loaves" was a 5-week study of the local fishing industry with a focus on environmental challenges and sustainable fishing. The study culminated in a delicious meal of steamed mussels (donated by local fisherman Phil), local bread, and roasted vegetables (all obtained from local farmers).

HUNGER: For the first time, letter-writing campaigns were held for Bread for the World (an outreach that seeks no money and is an excellent example of Faith in Action to change the World) and resulted in over 100 letters mailed to our various elected officials in support of extending the Child and Earned Income Tax Credits. In addition to collecting food throughout the year for the Mid Coast Hunger Prevention Program, we held 'food drives' for MCHPP at Thanksgiving collecting \$120 and were thrilled to deliver 100 pounds of food collected during the Cul de Sax Christmas Concert.

BLOOD: We continue to provide the space, volunteer hosts and donors for the American Red Cross Blood drives.

HOMELESSNESS: A number of Faith in Action Team members have been part of an exciting new project in downtown Brunswick, "The Gathering Place" which will provide an open and welcoming place for people to meet, chat, and socialize – addressed primarily to folks who have no place to go during the daytime. A future hope is to provide connections to local support programs, computer and life skills, and guidance in seeking employment.

AFFORDABLE HOUSING: As a covenant church for Habitat for Humanity since 2004, we continued to support Habitat for Humanit/7 Rivers Maine by participating in the Annual Walk, which raised over \$1800 from MCPC and by selling "gingerbread house cookies" to raise additional funds. Exciting news has arrived that a "build" will finally begin in Topsham and MCPC will serve as the hub for this ongoing project by providing space for meetings, recruitment and volunteer training. Of course, a number of members are expected to participate in the actual building of a new home for a local family.

FENCES IN SOUTH AFRICA, AIDS and GLOBAL HUNGER: For a number of years now, MCPC has been connected to Presbyterian workers and congregations in Africa. Originally paired with three different congregations in South Africa, MCPC has continued to be a strong supporter of the Khobonqaba Presbyterian Church's Soup Kitchen. As we continue to support the Mission At The Eastward's ongoing efforts to participate in pastor and congregational exchanges, we've also learned about the woefully inadequate availability of necessary medication and medical support of a population devastated by the AIDS epidemic. MCPC was able to send over \$900 to "Dr. Norma's AIDS clinic" in South Africa.

Fellowship of Portland made up of immigrants from Sudan who worship in their native Nuer language. Both financial support and dedicated leadership has continued to come from this congregation through monthly Steering Committee meetings and monthly joint worship services. Even as we have helped this immigrant population adjust to the American way of life, we have also learned about the long history of Presbyterian presence in Sudan, the incredible challenge for Christians in a predominantly Muslim country, and we've taken a personal interest in the outcome of the historical vote for independence currently taking place in Southern Sudan. Needless to say, involvement with our African Brothers and Sisters has enlarged our concept of the Body of Christ.

HOW TO SUPPORT OUTREACH WITH MORE THAN MONEY: Challenged by a significant budget deficit, we maintained our annual pledge to PCUSA (\$6,600) as well as continued support of denominational offerings (One Great Hour of Sharing, Pentecost, Peacemaking and Christmas Joy). In an effort to make up for our reduced financial support of the many agencies we've helped in the past, we highlighted the following agencies as a "Monthly Outreach," inviting local speakers to address the congregation and encouraging individual donations of time or money: Topsham Heating Assistance, Warm Thy Neighbor, Mid Coast Hunger Prevention Program (MCHPP), Chans Hospice, Mission at the Eastward (MATE), All About Prevention (formerly Merrymeeting Aids Support Services), Amnesty International-Maine, Greater Bath Elder Outreach Network, People Plus, Habitat, South African ministries (Dr. Norma's AIDS clinic, Khobonqaba Soup Kitchen), and a homeless day center being established in Brunswick.

VOLUNTEER OPPORTUNITIES IN THE LOCAL AREA: A Volunteer Opportunity Fair held this past Fall brought 20 agencies to Mid-Coast to describe their services and volunteer opportunities, providing a chance for the community to learn more about how they can help. It was enthusiastically appreciated by the agencies as an opportunity to network with each other and we hope to repeat the Fair again in the coming year.

ALTERNATIVE CHRISTMAS MARKET: How do we counter the commercialism and rampant materialism of Christmas? Our "Alternative Christmas Market" supported people around the world through sales of fair trade coffee, CEOLI cards, Heifer animals, fencing for gardens in South Africa as well as handcrafts made in South Africa, and Habitat for Humanity building materials.

HOSPITALITY TO THE COMMUNITY: These local organizations received support through the use of our building for meetings. Most pay no rental fees while others provide some monetary support to offset the cost of maintenance, heating, and all that goes into providing a welcoming space for the community to gather: Girl Scouts (four troops), Brownies, Venture Scouts (girls and boys), Cub Scouts, Mt. Ararat High School Nordic Ski Team, Youth Alternatives Mediation, Merrymeèting Wheelers Bicycle Club, American Red Cross, Food Addicts, Midcoast Winter Farmers' Market Association, Oratorio Chorale, and Brunswick Area Interfaith Council. #### Annual Report - 2010

Bright Start at Mid-Coast Presbyterian Church is a mission program that provides child care services and early childhood educational programs to children in the local area. We offer full-time child care for children ages 2  $\frac{1}{2}$  to 6 years of age. We are open from 6:30 am to 5:30 pm each day. We also offer a morning preschool and an afternoon K-Ready module. These programs can be accessed alone for families not requiring child care.

At the end of 2010 we had an enrollment of 41 children. Scholarship aid has been given to 9 children during 2010 totaling \$8,658. Seven children have received support from outside agencies such as the ASPIRE program and Child Development Services. We have provided a place for services for 11 special needs children. We provided services for three of these directly and carried out IEP's for the rest during our regular classroom time.

All staff renewed their CPR certification this year. We currently have five full time staff, including the director. We also are fortunate to have several volunteers, three from MCPC and one from Success by Six who read to us each week. Our volunteer from the Center for Independent Living continues to bake for us two times a week and we enjoy the wholesome muffins and breads for our snacks. We also had a volunteer this year from the community and a visitor from Sweden who has been helping out.

The children have enjoyed special activities this year in trips to the Topsham Library, the Highlands, our local Hannaford store, Petco, Home Depot, and our Kinder Konzerts. We adopted a former Bright Start family this Christmas and were able to provide them with many gifts and two boxes of food due to the generosity of our staff and parents. In July we visited the Portland Children's Museum for our annual family field trip.

The Board of Directors meet monthly at the church. It is composed of Linda Pappin, Marci Clark, Shirley Reese, Debbie Patterson, Joanne Hardy, Diane Hoppe-Hugo, Amy Goodwin and Loralie Spooner as well as Director, Eileen Twiddy. Joanne continues as our Treasurer and Linda Pappin serves as the liaison to the Session.

The Board and Staff are very grateful for the support of the church in our ventures. The property committee worked with staff to strip and wax the floors in our classrooms. A volunteer group from Bowdoin College was also able to paint the hallway in our wing.

It has been a busy and productive year and we look ahead to another great year at Bright Start.

## Annual Report for Faith In Daily Life Team- 2010

This faith team was a new idea that originated at the Elders-Deacons Retreat in January of 2010. The overall goal for this team is year-round stewardship as more than a Fall "Pledge Campaign". Our struggle has been to define "stewardship" and to define what this "stewardship" encompasses for us here at Mid-Coast both as a church and as a church family.

We presented the following to the congregation when we instituted the Faith Teams last year: Faith in Daily Life (Stewards take care of the household. How are we good stewards of God entrusting to us the world and life?)

Stewardship of Personal Finances (pledge campaign)

Stewardship of Creation (earth appreciation. restoration)

Stewardship of the Body (health, nutrition, exercise, sexuality)

Stewardship of Time (Sabbath)

Stewardship of Technology (emails, communications, and website)

Stewardship of Mind (emotional balance)

Stewardship of Citizenship (informed decision-making, with Jesus in mind)

Stewardship of New Members and Volunteers (nurture, talents)

Stewardship of Tradition (history, ritual, future)

Stewardship of Vocation and Talent (God's call, meaningful work, the arts)

Some of these goals overlap with the interests of other faith teams, but this is not uncommon in most families - sometimes the kids make supper; sometimes the whole family does the yard work, etc.

In our church brochure that we give to new visitors of our church, we describe the Faith in Daily Life Team vision:

In an effort to care for our world and each other, we seek to use our individual gifts together. Discerning those gifts as well as how to best care for God's creation and people is an ongoing process to which this congregation is dedicated. We seek to become better caretakers of all God has given us through time, talents, and our finances. No contribution is too small and we respect every individual's particular way of giving. As a family, we honor and love one another through hard times and in the joy of living as a people of God.

#### The bigger questions require discernment and reflection:

How is this congregation reflecting fiscal responsibility? How is the congregation exhibiting care of God's creation? How are we good stewards of our own health and wellbeing? How can our lives be examples of faithful stewardship in our workplaces and the secular and consumer-driven world?

#### Lastly, what is the future of the financial "stewardship"?

Having a year-round stewardship program in 2010 was a goal of session in the fall of 2009. Furthermore, PCUSA and PNNE encourage local congregations to develop year-round stewardship programs. Consequently, the initial main focus of this new team in 2010 was to begin to develop year-round financial stewardship at MCPC. Although the ultimate responsibility and planning for this lies with the Session, the team worked to stimulate session to begin to address this as a church family.

Clearly there are many opportunities and challenges for 2011 as we develop this Team further. If interested in this unique, challenging opportunity, feel free to offer your time and talent to focus our team on what God sees for the future of Mid-Coast in the stewardship of our home, our nation, and our world.

#### Annual Report for the Faith In Nurture Team 2010

The Faith in Nurture Team, as described on our website:

We explore our faith through opportunities to study scripture and learn more about what we believe. These opportunities offer a chance to reflect on the meaning of church membership and sacraments, and how to articulate our faith with one another and the world. In addition to providing educational opportunities for all ages, this team sought to create intergenerational events which would include all the members of our church family. The team included Elders, Marci Clark, and Anne Allen, working with Deacon Balinda Washington but much of what was accomplished depended upon the energy and commitment of many other congregation members, too many to name here so consider yourselves gratefully thanked!

Church School: Children begin worshipping with their family in the sanctuary. After the "Word to Young Christians," they are invited to go to age appropriate classes to learn about God's love for them. This year, a special series on Communion was led by elders Shirley Reese and Marci Clark. They were the first of a series of "Teacher of the Month" in an effort to draw upon the varied skills and experience of the entire congregation as well as allowing for teachers to be able to attend worship. Summertime saw a "one-room class" approach. This year has seen the involvement of a number of Youth members teaching the classes. We continue to need Adult involvement as helpers (to give one-on-one assistance and help prepare snacktime).

In addition to education, the Faith in Nurture team actively pursues opportunities for the children to be present and participating in worship. This included the delightful "Children's Sabbath" complete with a clown and posters designed to encourage caring for our earth; and the wonderful Children's Pageant where the children presented a live nativity as the Christmas story unfolded in lessons and hymns. This year also saw the creation of a new Children's Choir, led by Matile Hugo. Every Sunday, the children are introduced to the upcoming "first hymn" and learn songs to be sung for the congregation (to the delight of all!).

Youth Group (6 – 12th grade) meets one to two times a month for dinner, games, discussion, and service projects. What a thrill to be able to send 4 youth members and 2 adults to the Presbyterian Youth Triennium at Purdue this summer! This was made possible through a legacy from Harold Noyes who left a sizable bequest for the express purpose of making sure young people could attend spiritually strengthening and uplifting conferences. The team is especially grateful for Roy DeFio's continued oversight of the Youth Group.

Adults: "Coffee Pot Seminars" are offered throughout the year during the hour preceding worship, some of the offerings included: Globalization We Can Grasp; The Imagery of Heaven & Hell/Saints & Sinners/Vices & Virtues; The "E" Word, and an Eye-Opening Orientation to the Israel/Palestine Conflict. Two study series were offered this past year. In conjunction with the popular Soup and Bread Meal held every Thursday during Lent, people gathered to learn more about "Forgiveness" beginning with a compelling video "The Power of Forgiveness;" the series ended with a Seder Meal on Maundy Thursday. Following Easter, a second series was held in conjunction with the Faith in Action Team, "Fishes and Loaves," dealing with sustainable fishing and community-based food programs. That series was capped off by a dinner using locally harvested mussels and vegetables.

Nurturing our Spiritual Life through food and fellowship: by sharing meals and getting to know each other better, we find our faith strengthened within this community. A number of meals were overseen by the Faith in Nurture Team including a Fat Tuesday Pancake and Sausage Dinner (unfortunately, it was "iced" out and was postponed to a later date in Spring; proceeds were sent to support recovery in Haiti), an indoor picnic to celebrate our Youth as they headed off to Triennium, as well as a "Homecoming" potluck as we returned from summer destinations and a potluck following a successful Children's Pageant. On Palm Sunday, we held an Intergenerational Egg Decorating Event and in June, we began "Brown Bag and Games" held every month on the third Thursday beginning at 5:00 pm. People and kids bring their supper, we eat together and play games. It gives the kids, parents, and other participants a chance to get together and just have fun.

The Faith in Nuture team meets every three months with the Faith in Worship team and welcomes any and all ideas that will sustain our relationships with each other and strengthen our faith!!

## Annual Report on the Faith in Worship Team 2010

Where else could you encounter a clown, an energizer, an electric guitar, colorful streamers, biblical women, children creating posters as the congregation prays, and the assorted characters of the Christmas Nativity (uniquely including a pig)? That, and more, has been a part of the weekly Sunday worship services held here at MCPC, 10:10 am. On the back page, you will see many Worship services to remember – all of which included the preceding tantalizing images!

The Faith in Worship Team saw much transition in the last year. Initially, the Team met on a monthly basis to plan for and then review special worship services. A large part of the early discussions were devoted to addressing the best way to continue the tradition "Coffee Hour". With a "zero budget," this was a special challenge as was the desire to offer more healthy choices. Efforts to streamline the process were made and donations continue to be gratefully accepted. Joan Coop was most instrumental in maintaining weekly coverage and supplies. Currently, "Coffee Hour" following worship depends upon folks signing up in advance and then putting their gracious *volunteer* efforts to work making hot and cold beverages and bringing the snacks. There are some unsung "heroes" who have been a part of this process and are unlisted, including Joanna Damon, who brings her extensive knowledge of art to help with visual imagery for various special services of worship. She is a wonderful preacher and along with Bill Coop, Joan Coop, George Hardy, and Liz Washington, covered the pulpit whenever our pastor was away.

It has been a special joy to have the Youth of MCPC take over worship planning and leadership every "Fifth Sunday." They bring innovation and incredible energy which is enthusiastically supported by this congregation. Roy DeFio, Adam DeFio, Balinda Washington, Liz Washington, and Josh Mackin have been especially dedicated and involved in the process (along with Josh Grassman, these were the attendees to the Presbyterian Youth Triennium – hmmm!). A persistent leak in the bell tower was evident throughout the year. John Hilton has been engaged to resolve the problem as soon as possible in 2011.

All possible effort has been made to **work within the budget limitations**. In the spring the Committee launched a request for paint for the New Wing. A final total of \$190 was received, and the work will be done after some of the problem leaks are resolved. A donation was made to the Restore of building materials still remaining in the new wing attic. Remaining unusable materials were taken to the dump.

As the growing season began, it was decided to use **volunteer help in mowing** to save the church \$1,700. Lenore Stanton donated an almost-new lawnmower. The following took at least one spin around the grounds during a hot summer: Pat and Ryan Mackin, Paul Brown, Darryl Johnson, Carolyn Melcher, Washington Family, DeFio Family, Bruce Rafnell, Buckley and Tad Hugo (hope we didn't forget anyone!). Jeff Doring, who spearheaded the project, put in many hours making sure the grounds of MCPC looked their best. The Property Committee is considering how to keep saving money while making the process less time consuming. The committee was pleased with the turnout of **20 volunteers for the Spring clean-up of the grounds**. Grateful for the open weather experienced in November, a goodly number of our members convened on Nov. 19, and a **thorough fall cleanup** of the grounds was accomplished. We look forward to spring when our maturing landscape plantings will need much pruning. *Do watch for an announcement (about April or May) and become one of our groundskeepers!* 

New landscaping has been done, primarily by Dana Cary, relocating our sign for better visibility as well as pruning the large front trees and the dense shrubbery on the east side of the driveway entrance. A new walkway was installed to the columbarium unit by Bob Crane and the landscaping in the area has matured and creates a serene atmosphere.

Russ Riendeau continues the task of managing **outside use of our facilities**. He is also very faithful in proper disposal of **recyclables**. The need for **additional shelving** in the Pastor's office was skillfully resolved by Bud Cherry. The budget saving continued as all members of the committee pitched in to cover for our janitor Vaughn's first week off ever, saving the church the cost of hiring outside cleaning services.

The committee accepted with sincere regret the resignation of Bud Cherry as chairman. Bud has been (and continues to be) tireless in his efforts to address the many problems and challenges constantly occurring in caring for a building such as MCPC, and our appreciation knows no bounds! We feel very blessed that he remains an active(!) member of the committee. Bob Crane valiantly stepped up to take on chairing the committee and we have happily welcomed John Aliberto and Darryl Johnson (Session representative) as new members of the committee.

Throughout the year members of the committee have addressed problems with leaks, power outages, heating glitches, repairs to broken hinges on the dumpster surround, toilet sealing, repair of driveway paving to correct water problem, carpet cleaning, resolving excessive summer heat in the offices - and many other tasks! As with our homes, the tasks that pop up are endless and MUST BE ADDRESSED. **Please give serious thought to becoming a member of our committee!** We meet every third Monday at 7:00 PM in the West Room and we ask only for a willingness to address our problems - no special skills - we are all learning!!

## TREASURER'S ANNUAL REPORT for the YEAR 2010

This was truly a "miracle year" from a financial perspective. The Session approved a 2010 budget with a deficit of \$64,715 but with faith that the MCPC family would come together to minimize or eliminate that deficit during the year. Thanks to prayers and very hard work from many, many people, that deficit turned into a \$16,425 gain (income higher than expense)! The key ingredient in this "miracle year" was the anonymous donation of \$30,000 IF the congregation could match that. And the congregation did just that by increasing pledging by \$12,700 from the January 31, 2010 level, by making one-time contributions of \$11,533 through the Valentine and Extra Giving programs and by raising \$8,588 from numerous fundraising efforts (Give and Go, Parking Lot Sale, Time and Talent, Holiday Fair and the Harvest Dinner). Expenses under budget by \$8,100 completed the "miracle year" story.

A major effort now before us is to assure that the "miracle" continues in 2011. With basically the same expense commitments and desires for 2011 and WITHOUT the matching \$30,000, added income will need to be raised from an increase in amount each of us can pledge, from new and innovative fund raising efforts and from increased membership. May our prayers and work result in another "miracle"!

**BALANCE SHEET:** The church's Total Cash Position has improved by \$16,617 to a total of \$141,797. The unrestricted portion has improved by \$19,488 to \$42,523. The anonymous gift of \$30,000 and our fundraising efforts were major reasons for this positive news. Note that of the \$12,456 in Accounts Payable liability, \$10,771 represents monies collected since 2001 for a Habitat for Humanity/7 Rivers build in Topsham that will take place in 2011.

OPERATING FUND: This fund tracks the financial health of the basic operations of the church. Operating income is primarily made up of pledge and non-pledge offerings and, especially this year, gifts and fundraisers. Money is earmarked to support basic expenses associated with staff, mortgage, office, Presbytery financial obligations and some mission contributions. These income and expense categories are what are budgeted each year. Note that 2010 was the first year that the Operating and Building Funds were combined. Operating Income now includes unified pledges that covered what had been labeled separately as Operating Pledges and Building Pledges. Operating Expenses now include mortgage payments.

Operating income of \$202,113 was \$73,040 above budget as a result of the extraordinary giving as outlined above.

Operating expenses of \$185,688 were \$8,100 below budget primarily because of \$3,457 in building expense savings, of \$1,368 in general office expense savings and of \$5,000 in savings resulting from a delay in billing for a financial review into 2011. Essential Faith Team expenses that were not budgeted totaled \$1,418.

The net effect of over running income and under running expense resulted in an operating gain of \$16,425. This is especially good news when compared to an operating (and building) loss of roughly \$37,000 in 2008 and \$9,000 in 2009.

**OTHER FUNDS**: The church has non-operating funds made up of restricted funds (such as Columbarium, Noyes, National PC(USA) Offerings, Miscellaneous Collections & Expenses -Restricted) and unrestricted funds (such as Trust, Miscellaneous Collections & Expenses - Unrestricted). The combined balance decreased \$1,123 from the end of 2009 to the end of 2010.
